## **2007 History & Innovation Awards honors:**

## William A. Hinton, MD for Innovation in Healthcare

The son of slaves and the first African American to hold the rank of Professor at Harvard University and Harvard Medical School, Dr. Hinton was a pioneer in studying sexually transmitted diseases. In 1927, as director of a Harvard lab and chief of the Boston Dispensary's lab (now NEMC), Hinton developed a test for diagnosing syphilis, at the time among the planet's most feared scourges. The Hinton Test changed the world. Dr. Hinton contributed to a number of Boston institutions, working as a volunteer assistant in the Department of Pathology at MGH when he first graduated medical school, and later teaching at area colleges such as Simmons College and Tufts College School of Medicine and Dentistry. He also created a program to train women as lab technicians at the Dispensary.

Hinton's accomplishments are being honored and supported by the Boston History and

Innovation Collaborative and a committee drawn from different teaching hospitals across the city. The Committee is working to promote this particular award- and more importantly to help build awareness both within Greater Boston's physician community and outside of it of Hinton's role, to make him more of a folk hero. Dr. JudyAnn Bigby, Massachusetts Secretary of Health and Human Services, will present the Innovation in Healthcare award honoring Dr. William A. Hinton's achievements. Some of the proceeds of the awards dinner will support the Task Force's work.
